Dear Parent/Carer

Re: Final Week of Summer Term 2020

During the final week of the summer term in July 2020, students in Years 7 to 9 will take part in an Enrichment & Rewards Week. Year 10 students will be on Work Experience during this week but will still have the opportunity to participate in a Rewards Trip, details of which will be distributed by Miss Hemmings in due course.

The thinking behind these activities which will offered during this Enrichment & Rewards Week is to engage our learners away from the classroom by giving them a variety of learning experiences, the likes of which are not normally available during the school day and celebrate with the majority of our students who consistently behave well and attend school regularly.

Enrichment Activities

A letter and booklet will soon be distributed to parents/carers detailing the enrichment activities available to our students this academic year.

All students in years 7 to 9 must choose an enrichment activity to follow for the three days detailed. Behaviour and attendance does not affect which enrichment activity you can choose.

NB: If your son/daughter is taking part in the French or German trips during the final week of term, then they do not need to choose an enrichment activity.

Rewards Trip Years 7 to 9

We want this trip to be a reward to our students who consistently make the right choices with regard to their attitude and behaviour around school. Anyone who does not make the right choices within school will not be allowed to participate in these Reward Trips. The criteria for your son/daughter being allowed to attend the Rewards Trip are as follows:-

- 1. He/she has not reached 25 or more Low Level Disruption (C1) points.
- 2. He/she has not had 6 or more detentions (either C3, Pastoral Detentions or Subject Detentions combined).
- 3. He/she has not had 2 or more School Detentions.
- 4. He/she has not been in the Inclusion Room 2 or more times.

- 5. He/she has not had 3 or more C4s
- 6. He/she has not been excluded (internally or externally)

This will be based on sanctions accrued between Wednesday September 4th 2019 and Friday 26th June 2020.

Full payments for the rewards trips will be due in by **Friday 1st May 2020** and will be non-refundable.

If your child's behaviour fails to meet one or more of the criteria before **Friday 26th June 2020** they will be withdrawn from the trip and no money will be refunded, if payment has been made. In addition, if there is a serious behaviour incident after this date the School reserves the right to also remove students from the trip with no money refunded. The School's decision on this is final.

For any student who does not want to attend the trip or is not allowed to because of their behaviour, they will follow a timetable of activities in school.

Any questions or queries regarding the Rewards Trips should be directed to your son/daughter's Progress Leader.
