Photos, videos and school work

During the course of the school year, we may sometimes wish to take photographs or video recordings of children within school or on school trips, either for our own records, for use as part of our learning curriculum or for inclusion in our promotional material such as the school prospectus and our website. Biometric data

We use what is known as 'biometric data' in school. Specifically, we use your child's fingerprints. We use 'biometric data' to enable your child to benefit from the 'Cashless System' in school.

For our 'Cashless System' we use a biometrics system (fingerprint) to allow the students to purchase items from our Canteen. When the fingerprint is created the biometric information taken is an algorithm, not the actual thumbprint, and is converted into a unique number that links to the student. ParentPay, the company responsible for payment, verifies the unique number to identify the student account in order for payment to be processed.

We'd like your consent to use your child's fingerprints in the ways listed below. This information is held securely in school, and helps us operate these systems more efficiently. If you choose not to have your child registered, the school will provide alternative methods of identification such as a 4-digit PIN code or Smart Card.

We should be grateful if you would indicate whether or not you give consent by indicating with a tick (\checkmark) – by indicating with a tick you are confirming that you consent to your child's personal data being shared for those purposes and/or with the named third parties.
