How do I ensure I am successful in Health and Social Care?

- Do not wait until the final deadline to hand in coursework. If you do you
 will not get as many opportunities for feedback. Ask questions in class
 and get immediate live feedback.
- For non-examined assessment ensure you have remembered the 3 magic rules when completing a task:
 - 1) Have I met the requirements of the command verb?
 - 2) Have I met the plural rule?
 - 3) If appropriate have I applied my work to the relevant care environments?
- RAG rate your topic checklists or specification and identify which areas
 you most need to focus on. If you do not understand some of the
 content read the relevant textbook chapters and come to a drop in
 session to go over them.
- Produce a summary sheet (template given in class) for each of the
 malfunctions in the specification that covers, biological causes, risk
 factors, physiological explanation, diagnosing, monitoring, treatment
 (medication and surgery), care needs and the impact on PIES and
 activities of daily living.
- Ensure you can evaluate the advantages and disadvantages of the different types of treatments.
- Access past papers, mark schemes and examiners reports to increase familiarity of what the exam will be like.
- Revisit feedback in your assessment books and improve the questions.
